4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

Inhalation: Remove person from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow person to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

Skin Contact: If skin or hair contact occurs, remove contaminated clothing and flush skin and hair with running water. If swelling, redness, blistering or irritation occurs seek medical assistance. For gross contamination, immediately drench with water and remove clothing. Continue to flush skin and hair with plenty of water (and soap if material is insoluble). For skin burns, cover with a clean, dry dressing until medical help is available. If blistering occurs, do NOT break blisters. If swelling, redness, blistering, or irritation occurs seek medical assistance.

Eye contact: Immediately irrigate with copious quantities of water for 15 minutes. Eyelids to be held open. Remove clothing if contaminated and wash skin. Urgently seek medical assistance. Transport to hospital or medical centre.

Ingestion: Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water to drink. Never give anything by the mouth to an unconscious person. If vomiting occurs give further water. Immediately call Poisons Centre or Doctor.

PPE for First Aiders: Wear rubber boots, overalls, gloves, apron and chemical goggles, dust mask. Available information suggests that gloves made from butyl rubber, natural rubber, nitrile rubber, neoprene or polyvinyl chloride (PVC) should be suitable for intermittent contact. However, due to variations in glove construction and local conditions, the user should make a final assessment. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storing or re-using.

Notes to physician: Treat symptomatically. Can cause corneal burns.

5. FIRE FIGHTING MEASURES

Suitable extinguishing media: If material is involved in a fire use extinguishing media suitable for surrounding fires.

Specific hazards: Non-combustible material. However, on evaporation of the aqueous component, residual material may burn.

Fire fighting further advice: Keep containers exposed to extreme heat cool with water spray. Fire fighters to wear self-contained breathing apparatus if risk of exposure to products of combustion or decomposition.

6. ACCIDENTAL RELEASE MEASURES

SMALL SPILLS

Minor spills can be rinsed with water and do not normally need any special clean-up measures, however it is a safety precaution to wear protective equipment to prevent skin and eye contamination. Avoid inhalation of vapours or dust. Wipe up with absorbent (clean rag or paper towels). Collect and seal in properly labelled containers or drums for disposal.

LARGE SPILLS

Clear area of all unprotected personnel. Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contamination and the inhalation of dust. Work up wind or increase ventilation. Cover with damp absorbent (inert material, sand, soil or vermiculite). Sweep or vacuum up, however avoid generating dust. Collect and seal in properly labelled containers or drums for disposal. Dispose of waste according to the applicable local and national regulations. If contamination of crops, sewers or waterways has occurred advise local emergency services.

7. HANDLING AND STORAGE

Handling: Corrosive solid; causes burns. Avoid eye contact and skin contact. Avoid inhalation of dust. Wear protective clothing when risk of exposure occurs. Avoid contact with incompatible materials. When handling, DO NOT eat, drink or smoke. Keep containers closed at all times. Avoid physical damage to containers. Always wash hands with soap and water after handling. Work clothes should be laundered prior to reuse.

Storage: Store in a cool, dry, well-ventilated place and out of direct sunlight. Protect from freezing. Store away from foodstuffs. Store away from incompatible materials described in Section 10. Store away from sources of heat and/or ignition. Store locked up. Store in corrosive resistant container with a resistant inner liner. Keep container standing upright. Keep containers closed when not in use - check regularly for spills. Ensure that storage conditions comply with applicable local and national regulations.

This material is classified as a Class 8 Corrosive as per the criteria of the "Australian Code for the Transport of Dangerous Goods by Road & Rail" and/or the "New Zealand NZS5433: Transport of Dangerous Goods on Land" and must be stored in accordance with the relevant regulations.

TWA - The time-weighted average airborne concentration over an eight-hour working day, for a five-day working week over an entire working life.

STEL (Short Term Exposure Limit) - the average airborne concentration over a 15-minute period which should not be exceeded at any time during a normal eight-hour workday.

These Exposure Standards are guides to be used in the control of occupational health hazards. All atmospheric contamination should be kept to as low a level as is workable. These exposure standards should not be used as fine dividing lines between safe and dangerous concentrations of chemicals. They are not a measure of relative toxicity.

If the directions for use on the product label are followed, exposure of individuals using the product should not exceed the above standard. The standard was created for workers who are routinely, potentially exposed during product manufacture.

Biological Limit Values: As per the "National Model Regulations for the Control of Workplace Hazardous Substances (Safe Work Australia)" the ingredients in this material do not have a biological limit allocated.

If engineering controls are ineffective at maintaining airborne concentrations below Exposure Standards, suitable respiratory protection must be worn.

Available information suggests that gloves made from butyl rubber, natural rubber, nitrile rubber, neoprene or polyvinyl chloride (PVC) should be suitable for intermittent contact. However, due to variations in glove construction and local conditions, the user should make a final assessment. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storing or re-using.

A face shield can be used in conjunction with chemical goggles for supplementary protection of the face, however never for primary protection of the eyes. A chemical resistant apron is recommended where large quantities are handled. If engineering controls are insufficient at maintaining dust concentration levels below exposure standards, suitable respiratory protection must be worn.

Hygiene measures: Keep away from food, drink and animal feeding stuffs. When using do not eat, drink or smoke. Wash hands prior to eating, drinking or smoking. Avoid contact with clothing. Avoid eye contact and skin contact. Avoid inhalation of dust. Ensure that eyewash stations and safety showers are close to the workstation location.

10. STABILITY AND REACTIVITY

Chemical stability: This material is stable when stored and used as directed.

Conditions to avoid: Extremes of temperature and direct sunlight.

Incompatible materials: Acids, aluminium, magnesium, zinc alloys and carbon dioxide

Hazardous decomposition products: Thermal decomposition may result in the release of toxic and/or irritating fumes.

Hazardous reactions: Reacts vigorously with acids; violent reaction can occur, yielding heat and pressure, which can burst an enclosed container. Attacks many reactive metals releasing highly flammable hydrogen gas, which generates fire or explosion hazards. Reacts slowly with ambient air, particularly carbon dioxide, which may cause certain insoluble salts to form in solutions.

11. TOXICOLOGICAL INFORMATION

No adverse health effects expected if the product is handled in accordance with this Safety Data Sheet and the product label. Symptoms or effects that may arise if the product is mishandled and overexposure occurs are:

Acute Effects

Inhalation: Material may be an irritant to mucous membranes and respiratory tract.

Skin contact: Corrosive to skin – contact with skin will result in severe skin burns.

Ingestion: Harmful if swallowed. Swallowing can result in nausea, vomiting, diarrhoea, abdominal pain and chemical burns to the gastrointestinal tract.

Eye contact: Corrosive to eyes - contact with eyes will result in corneal burns and serious eye damage. Contamination of eyes can result in permanent injury. Exposure to the dust may cause discomfort due to particulate nature. May cause physical irritation to the eyes.

Acute toxicity

Inhalation: This material has been classified as not hazardous for acute inhalation exposure. Acute toxicity estimate (based on ingredients): $LC_{50} > 5.0$ mg/L for dust.

Skin contact: This material has been classified as not hazardous for acute dermal exposure. Acute toxicity estimate (based on ingredients): $LD_{50} > 2,000$ mg/Kg bw

Ingestion: This material has been classified as a Category 4 Hazard. Harmful if swallowed. Acute toxicity estimate (based on ingredients): 500 mg/Kg bw

Corrosion/Irritancy: Eye: this material has been classified as a Category 1 Hazard (irreversible effects to eyes). Causes severe skin burns. Skin: this material has been classified as a Category 1B Hazard (irreversible effects to skin). Causes serious eye damage.
